### Reg 31 and training requirements

#### Regulation 31

Regulation 31 states that all chemicals and construction products used by water undertakers, from the source of the water (point of abstraction), up to the point of delivery to the consumer's building must be approved and must not prejudice water quality and consumer safety

As in this example, failure to check that materials are fully Reg 31 approved before being purchased can result in us having spent money on equipment that we can't use!

Failure to use Reg 31 approved products can severely effect water quality leading to taste, odour, appearance and microbial growth issues!

It is against the law not to comply with Reg 31 and it is one of the few regulations that we can be prosecuted or fined for breaching!

The consequences for not complying with Reg 31 can be large fines or even a custodial sentence!

It is a criminal offence not to comply with regulation 31

It is important to ensure that equipment and materials coming into contact with water intended for supply, are Regulation 31 approved

#### Materials in contact

The Materials In Contact (MIC) process is the process that Anglian Water uses to record and track products used and ensure that they are compliant with Regulation 31.

We need a list of materials that you to use at each specific site visit, this list should provide;

• Product Name

- Manufacture Name
- DWI Approval Number for Pipe types used
- WRAS Approval number for fittings
- At this time we are not going to insist that they provide the instructions for use, but this may be a future requirement.

How you choose to send us this information is up to you. The format can be as preferred by the individual company as long as it contains the information.

#### **Training**

There are many different training offerings depending on the work the SLP wants to be undertake.

Some are delivered by us via classroom-based sessions and others are delivered directly to the operatives by someone within the SLP who's accredited to be a train the trainer.

We reserve the right to audit any construction work to confirm that all training's in date.

Training is role specific depending on what work you need to do.
