Thank you for your request for information about pig farms, which we received on 2 April 2026. Your request has been considered under the Environmental Information Regulations 2004 (EIR).

You requested:

1. Any record of intensive pig farming installations housing more than 750 breeding sows or 2,000 production pigs over 30kg operating within 2km of any Anglian Water owned land, water abstraction points, reservoirs, treatment works or waterways

EIR Response: Refusal of Requested Information

Item 1 is not held by Anglian Water.

Anglian Water does not hold records of the locations of intensive pig farms housing more than 750 breeding sows or 2,000 production pigs over 30kg.

This information on the locations of intensive pigs housing more than 750 breeding sows or 2,000 production pigs over 30kg may be held by the Environment Agency.

The duty to make information available to you under EIR Regulation 5(1) does not arise because in accordance with EIR Regulation 3(2) we do not hold the information you have requested.
