The group discussed the implications of this and the need to find internal funding solutions.</li> </ul> <p>[REDACTED]: emphasised that these sites must proceed as planned, and the company needs to find a way to fund them internally.</p>

		<p>■: suggested issuing holding objections for planning applications related to these sites until the company decides on its approach, particularly in light of the potential CMA redetermination.</p> <p>■: asked for more details about the specific developments in Huntingdonshire, as they have an upcoming meeting with ■ of Huntingdonshire District Council.</p> <p>■: agreed to provide the necessary details.</p> <p>The urgency of responding to planning applications was highlighted, with a recommendation to issue holding objections until the end of February to allow time for a decision on the CMA redetermination.</p> <p>The importance of these sites for growth and compliance was discussed, with a consensus that they need to be delivered to avoid regulatory issues and support future growth.</p> <p>ADP Meeting with strategy and regulation teams (afternoon of 10<sup>th</sup> Jan) to discuss this in more detail.</p>
