Thank you for your request for information about test results for the pesticide Carbetamide in potable and raw water, which we received on 30 July 2024. Your request has been considered under the Environmental Information Regulations 2004.

Please provide each drinking water sample results taken by your company in the year 2022 to present day (30/07/2024) for the following pesticides: Carbetamide

As requested, the results for each carbetamide analysis in the date range specified have been provided in Excel format.

Please mark if the result of each sample **was more than** 0.000 ug/l in concentration (including if the result is between 0.000 ug/l and 0.007 ug/l).

All individual sample results have been listed and the result is given for each sample. All treated drinking water results (apart from one, which is was from a supply that is always further blended) are below the analytical limit of detection and these are symbolised with a 'less than' symbol thus '<'. The limit of detection and the appropriate result is listed against the sample location with date.

Please provide a breakdown of the number of samples that are above the regulatory limit of 0.1ug/l that applies in drinking water.

I can confirm we have had no breaches of the 0.1 microgram per litre ($\mu g/l$) standard for carbetamide in drinking water.

Please also provide the results for each sample result at the abstraction monitoring point taken by your company, and the name of the abstraction point, from 2022 to present day (30/07/2024) for the following pesticides: Carbetamide

As requested, the results for carbetamide analysis from river intake locations and from bore holes have been included in Excel format.

Please provide a breakdown of the number of samples that are above the regulatory limit of 0.1ug/l that applies in drinking water.

There were two river intake (raw water) samples in 2022 which were 0.18 and 0.136 µg/l.

Please mark if the result of each sample **was more than** 0.000 ug/l in concentration (including if the result is between 0.000 ug/l and 0.007 ug/l).

All individual sample results are provided in the Excel spreadsheet.
