## **Provision of requested information**

Thank you for your request for information, which we received on 8 November 2024. Your request has been considered under the Environmental Information Regulations 2004.

Your requests was as follows, with the answers beneath the question.

1. How many of your sewage pumping stations have an storm overflow tank on? How many of these old storm tanks have an emergency or storm overflow pipe on please?

There are 199 storm tank on pumping stations in total. Some pumping stations have more than 1 storm tank at site. This equates to 150 sites. Unfortunately, the data held within SAP (system which manages or Work Management System and contains our assets) is not consistent or up to date so some of these may be decommissioned or not asset captured.

2. Please can you confirm these sewage pumping stations locations that have a storm overflow tank on and where their emergency/storm overflow pipes on the storm overflow tank discharges to please?

From the 150 sites identified as having a 1 or more storm tanks on site, 89 have a permitted storm discharge. There may be some discrepancies in our asset data due to the way they are recorded or due to their operating nature. Below are the station names and the grid reference locations which are on the permits where they discharge to.

3. Please can you confirm if the brick building located down Belchmire lane, Gosberton, right next to your sewage pump and wet well has an old emergency/storm overflow tank in there? I have information from the council, that they think that this old building is yours. Can you confirm its purpose and whether it was fully decommissioned?

Having searched the land registry I can confirm that the brick building is not owned by Anglian Water, so can not confirm what it's purpose is. The site was originally owned by the local Council, at that stage the Rural District Council of Spalding, who purchased the whole area in 1946. The land was purchased by the East Midlands Electricity Board on 10 November 1948 and the current owner is Western Power Distribution (East Midlands) PLC

4. Lastly can you confirm how many sewage treatment plants have been closed down in the last ten years, and their waste put onto other treatment plants please?

42 Water Recycling Centres have been closed in the last 10 years. Thy are listed below.
